The chief justice represented the pro-south or Chivalry wing of the Democratic party and the senator represented the free soil or anti-slavery wing of the Democrats. Although the Chivs won the duel, California was solidly antislavery and was pro-Union throughout. California showed its patriotism under the leadership of Rev. Thomas Starr King who raised a quarter of all funds for the Union Sanitary Commission [becoming the American Red Cross] nationwide. So a guarter of funds came from well under ten percent of the nation's population!
