### From Big SIR John McGlothlin: SIR Insurance Requirements and Their Effect on Our Events

This month I am writing about a very important matter because I believe it is important for you to know. Since the State

Organization's (State) original email was sent out on June 11<sup>th</sup>, Big SIR's and Branch Boards have been wrestling with the requirements and working to get better policies from the "State" Organization to cover events where we use caterers or other contractors.

This all started with a very serious problem. One Branch had an event, catered by a branch member. Ten members became ill, one was hospitalized and one passed away. I know you understand how serious that is. We don't know which branch it was and who was injured and that doesn't really matter; one person is one too many!

As a reaction we received orders to assure caterers and other contractors we used were insured and agreed to hold SIR harmless for mishaps at an event where they provide services to SIR. This is intended to protect SIR and SIR's insurer from claims. As we reviewed the State's mandates, many of us had concerns with the language and how to implement it. As we talked to caterers contractors they also expressed concerns EVEN WHEN THEY WERE INSURED. In addition to communicating our concerns, some SIR's who are attorneys drafted more suitable language and sent it to the State. We're waiting for a response.

This policy mandate affected the caterer we use for the picnic we host with Branch 91. Caterer Ryan Rawlings informed Branch 91 he would not cater our picnic. To complicate things further, Branch 91's Little SIR has been hospitalized and will not be able to coordinate the picnic. To date. Branch 91 has not located a replacement caterer and it is very possible we will not have a picnic. We may not know before the August Foghorn is distributed so a special notice may be necessary.

We all want our events to be safe and enjoyable. The most important step is to assure our caterers follow sound procedures and provide safe products and services. Insurance is no substitute for good, safe practices.

There are other State policies mandated regarding participation at events and I'll cover them in the future.


