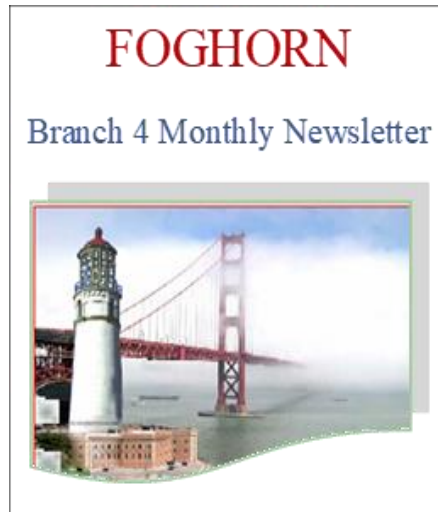
COVID19 flu shots can be scheduled at myturn.ca.gov if you have not already had them.
