# "An Exceptional SIR", by Dave Nigel.

This month's featured "Exceptional SIR Member" is Stu Etzler. Stu joined SIR Branch 4 in April 2012 and has served as Little and Big SIR, and as Speaker Coordinator. Stu was born at Children's Hospital in SF and grew up attending Parkside Elementary, Hoover Junior High, and graduated from Lincoln High School in 1964. While at Lincoln, Stu played football and threw the discus on the Track Team.

Stu attended City College, Sacramento, and San Jose State Universities, receiving his B.A. in 1971 in Metal Fabrication. While at City College, Stu met his wife Norma who came to San Francisco from Bogota, Colombia and they have enjoyed a beautiful life together.

Stu began his professional career in heavy construction with his first assignment working on BART at the Embarcadero station. At this time, he entered the master's program at Lone Mountain College earning his degree in Sculpture. Stu's next career stop was as a carpenter followed by involvement in the Construction business. Stu worked with Big Sir *emeritus* Stu Ruth on numerous projects.

A truly incredible accomplishment involved completing 432 Triathlons (a multisport race that involves swimming, cycling, and running) races and, sometimes other triathlon events including kayaking, windsurfing, roller blading, and skiing. Stu became Branch 4 Big Sir and served in that leadership capacity between 2019-2021:one of only 2 Big SIRs to serve 2 terms!
