What Is Going On With Our Organization? (I believe good things!), by John McGlothlin

Area 13 working together. I've have been involved in three initiatives to make SIR the best organization we can be. With a rotating cast of Bill Gipe, Stu Ruth and Tim Hazen, I attend Area 13 quarterly meetings. We share ideas, successes and things we wish would work better. Our test of paid advertising in publications like the Daily Journal was great idea that didn't work as well as hoped. We concluded face-to-face contact at Branch level is the best way to build our branches.

Branch Advisory Council (BAC). Over the last three+ years there is a change of emphasis towards listening to and supporting needs of local branches (i.e. Branch 4). We've had State Presidents who promote this including Rich Carlston, our outgoing President. Rich established a Branch Advisory Council to work to tackle issues. I was invited to participate and used the opportunity to involve our Big and Little SIRs in our Zoom conferences.

An outcome was consensus to tackle critical issues such as membership decline, attracting additional funding and improving tools such as the web Site you use to interact with SIR. Much has been accomplished. For those submitting reports to "the State" the interface is improved and simpler! If you want to look things up on our website, it is easier to search. You may have noticed our State President's monthly newsletter, "The Rooster Crows", President Rich Carlston wanted to reach more of us and insure we were informed!

Strategic Planning for SIR. SIRs Leadership identified issues we needed to address to move forward including funding. Funding for Information Technology improvements and outside contractors comes from the money each Branch is assessed. These assessments must make sense to the branches and should not interfere with our operations. We are also concerned about how we retain our non-profit status in an environment where all-male membership may meet legal challenges. We need to expand our recruiting base to attract more members who may be retiring and want to enrich their lives.

A working group was established to tackle each critical area. I've been asked to chair the group designing a mission and vision for the organization that supports our goals and will be supported by our membership. More to come!

Using New Tools to Improve Communications and Support. I mentioned above, improving interfaces and making searches easier. We've also brought Artificial Intelligence (AI) into our organization. To be honest, we're all neophytes, however, the potential for using AI to improve our written products is good. There was an orientation for SIR officers recently and I've started using the tool to polish documents and gear them towards our intended audiences (Co-Pilot is an AI capability built into Microsoft 365). I'm interested in finding a speaker to share knowledge with all of us! Suggestions, please!
